## Release of Liability and Waiver

Every entry at an NWRA recognized show shall constitute an agreement and affirmation that the person making it and the owner, lessee, trainer, manager, agent, coach, rider, handler, and the horse for themselves, their principals, representatives, employees and agents: 1) Shall be subject to the bylaws and rules of the North West Reining Association and the National Reining Horse Association 2) Represent that every horse, rider, and handler is eligible as entered 3) Agree to be bound by the bylaws and rules of the NWRA, and will accept as final the decision of the grievance committee on any question arising under said rules and agree to hold the show, NWRA, NRHA, their officials, directors, employees, and agents harmless for any action taken 4) Agree that as a condition of and in consideration of entry, they authorize the NWRA to market, transfer, assign, or otherwise make use of any photographs, likenesses, films, broadcasts, cablecasts, audiotapes, or videotapes taken of the horse(s) and participant(s) while on the show grounds in any way they see fit for the promotion, coverage, or benefit of the NWRA or the sport of reining, without compensation to any of them, and hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to invasion of privacy, right of publicity, or to misappropriation 5) Agree that they participate voluntarily in the competition fully aware that horse sports and the show involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold the NWRA, NRHA, the show and its officials, directors, employees, show facility, and agents harmless from and against all claims including any for injury or loss suffered during or in connection with the show, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent act(s) or omissions of said officials, directors, employees, show facility, or agents of the NWRA, NRHA or the show. **YOUR SIGNATURE INDICATES AGREEMENT TO AND ACCEPTANCE OF ALL CONDITIONS LISTED ABOVE. IN THE CASE OF A MINOR CHILD BEING ENTERED, THE PARENT OR LEGAL GUARDIAN OF THE CHILD MUST SIGN ON BEHALF OF THE CHILD.**
